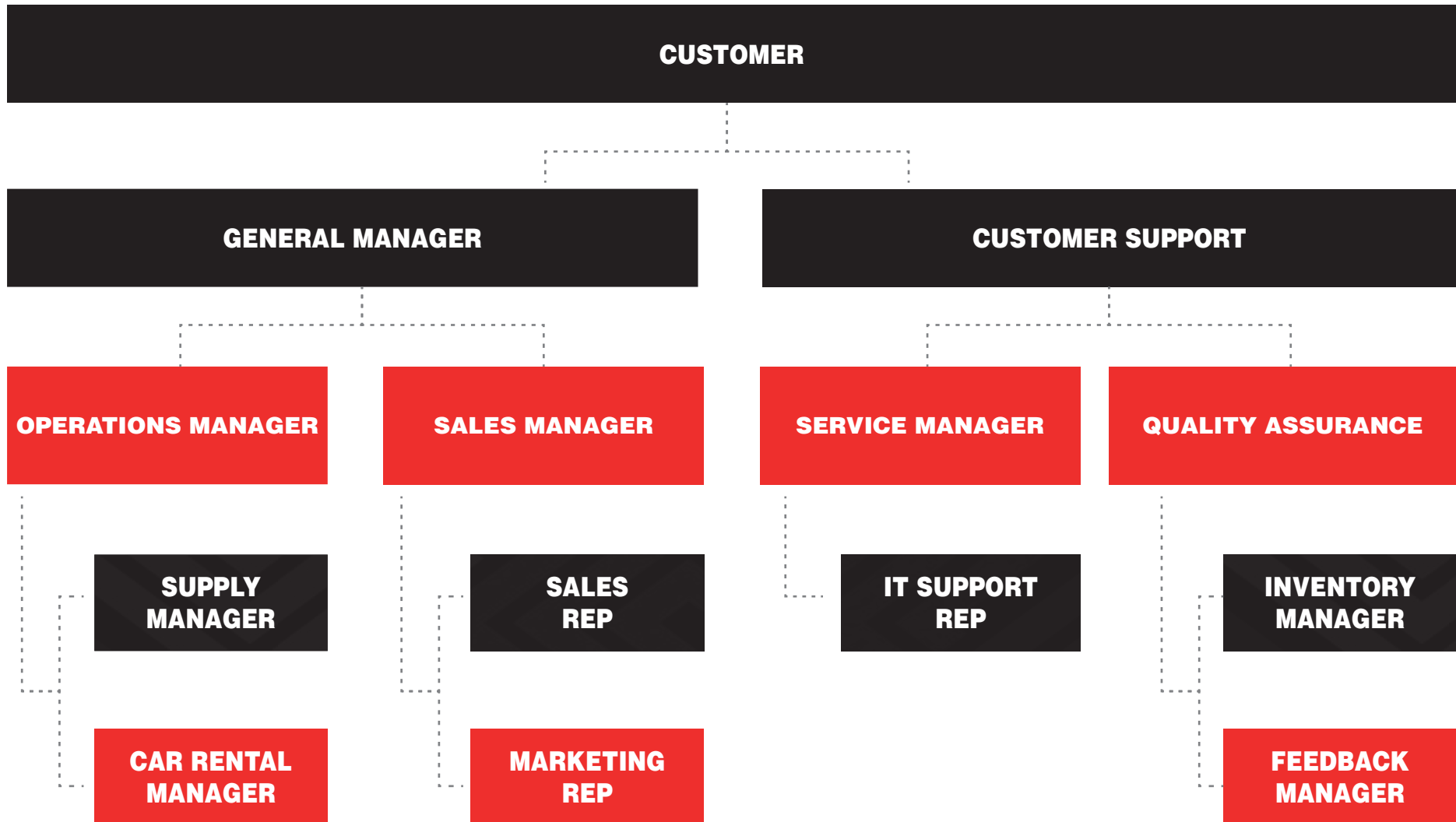

# Our Organizational Chart



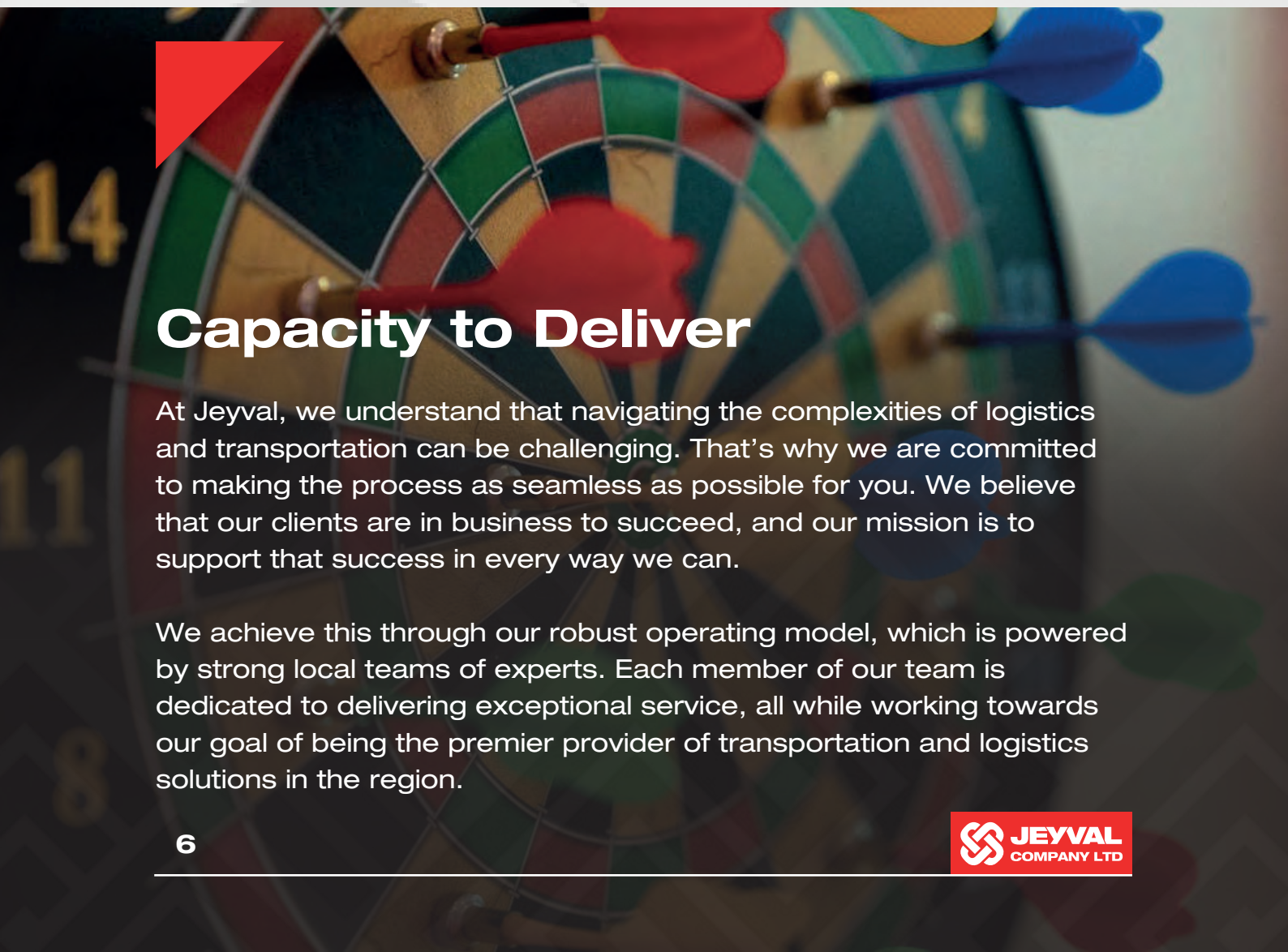
